**Issue of Shares
for acquisition of 20% Interest in PNG**

Gold Mountain Limited (“**GMN** or **Company**”) is pleased to announce that the Company has now completed the acquisition of the initial 20% of the entire issued capital of Viva No.20 Limited (“**Viva**”).

The 20% acquisition of Viva at completion is consistent to certain requirements of the Mining Act (PNG) whereby the transaction shall occur after the second anniversary of the registration of those exploration leases held by Viva. The term of the tenements which is to expire at the anniversary has also been renewed recently by the Mineral Resources Authority for another term of two years.

The issue of 50 million consideration shares at \$0.03 each to the Vendors are in accordance to the terms and conditions as set out in the Letter Agreement of 30 June 2014 and approved by shareholders at the Annual General Meeting held on 15 December 2014.

The issue of GMN shares to the Vendors are subject to a voluntary escrow arrangement for a period of 12 months and will be released from escrow on 22 March 2017.
