1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: It is reasonably expected that the Company will continue to have negative operating cash flows for the foreseeable future given its status as an exploration company.

It is also noted that control measures taken by the Company to scale down the level of exploration and to reduce discretionary expenditures in response to COVID-19 would minimise, if not alleviate the effects of negative operating cash flows.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: The Company has continuing support by certain shareholders who have agreed to provide temporary working capital loans in the aggregate of up to \$800,000. This will provide certainty of the company's operations in the immediate future.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: The Company expects to be able to continue its operations and meet its business objectives on the basis, without disruption to business that the company will be able to raise further working capital and to recommence exploration activities upon the lifting of travel restrictions.
