The Company expects to receive a preliminary round of placement funds of approximately \$2.0 million in which an announcement for the Proposed issue of securities would be released in November 2020.

The funds raised would be used for purposes of general working capital in support of the on-going drilling program at Monoyal Prospect.

The Company will continue to secure further funding to support the next stage of development on the wider areas of the Wabag Project including the prospective areas targeted at Sak Creek and Mt Wipi.
